Payment and Cancellation Policies

Music fees: (circle fees that apply)

\$100 – *Non- Refundable Deposit* (to Reserve your event date)

\$300/Hour – *Performance Fee* (per hour fee for string trio performance, if performing more than one hour, we request at least one 7-10 minute break per hour)

\$75 - *Rehearsal Fee* - if you require one of us to attend any event rehearsal if one of us is available.

\$75/hour + \$.50/mile – *Travel Fee* - applies if your event is more than 25 miles from Midtown Tulsa

Custom Music Request: Custom Requests are charged on a per song fee. Prices range from **\$5-\$25 per song** if we can purchase music. Custom Arrangements are a flat **\$35** per song. Requests and payment must be submitted to Save the Date Musicians no later than three weeks prior to your event.

\$100/hour - *Additional Musician fee (per musician)* - applies if you request any additional musicians, i.e. a quartet, different instrument (ex. Saxophone, guitar) etc.

\$125 - *Outside Musician fee* - this fee applies if we have to rehearse with another musician of your choosing.

\$50 - *Alternate Instrumentation fee* - this fee applies if you request an instrument available in within the performing musicians' scope that is not our standard instrument.

1. PAYMENT - A non-refundable deposit in the amount of **\$100.00** made payable to Save the Date Musicians is required to guarantee the booking of this event. Remaining balance of all other services shall be paid no later than seven (7) days prior to the event date, unless otherwise stated above. Payment Plans are accepted upon request. Payment is accepted by PayPal, credit card, cash or check.

2. OUTDOORS - It is understood that some musical instruments, particularly string instruments, are extremely valuable and are susceptible to damage when exposed to certain climatic variations such as rain, wind, direct sunlight and temperatures above 90 degrees Fahrenheit and below 55 degrees Fahrenheit. Therefore, performers must be provided with shelter from rain, snow, wind, or precipitation of any kind (under a tree is not acceptable cover), and direct sunlight in extreme heat. For outdoor events the temperature must be at least 55 degrees Fahrenheit and less than 90 degrees. The decision whether to perform outside will be made by the musicians at the time of performance, and you agree that their decision will be final. Performances may be moved indoors due to weather conditions. We do not supply cover of any kind. Supplying cover is the responsibility of the Client.

3. CANCELLATION -

a. If the primary members of Save the Date Musicians are unable to play an event, substitute musicians will take their place for that event if available. Save the Date Musicians reserves the right to cancel this Agreement without obligation upon notice to the client. In the event of cancellation by Save the Date Musicians, for any reason, client will receive a full refund of fees paid minus their deposit and the cost of any music purchased.

b. The Client reserves the right to cancel this Agreement prior to performance. In the event of cancellation by the client prior to seven (7) days before the event, Client will receive a full refund of fees paid minus their deposit and the cost of any music purchased. In the event of cancellation by the Client within seven (7) days of the event will require payment of any outstanding balance owed to Save the Date Musicians.

4. RESCHEDULED DATES - Changes to the originally agreed upon performance date will be looked at upon request. If we have the new date that you have requested free in our calendar, we will move to your new date at no additional cost, as long as there are no additional changes (duration, venue, etc.).

5. VENUE REQUIREMENTS - it will be the responsibility of the Client to ensure the following is available and provided at the venue

1. Three chairs **without arms**
2. Adequate lighting to read our music (we do have stand lights)
3. An 8' x 8' space to set up

6. VENUE CHANGES - Changing to a venue more than 25 miles outside of midtown Tulsa will result in a travel fee (see above).

7. Save the Date Musicians does not provide sound or lighting equipment.

8. FORCE MAJEURE - Neither the Client nor Save the Date Musicians will be liable for failure or delay to perform obligations under this Agreement because of circumstances beyond the reasonable control of the either applicable party. Such circumstances include without limitations natural disasters, or acts of God, acts of terrorism, labor disputes or stoppages, war, government acts or orders, epidemics, pandemics, outbreak of communicable disease, quarantines, national or regional emergencies, or any other cause beyond the party's reasonable control. The parties hereby agree, when feasible, not to cancel but reschedule the event for mutually agreed upon dates as soon as practicable after the force majeure condition ceases to exist.
