Services Offered

(Check all fees that apply)

\$725 – *Ceremony or Cocktail Hour Package* - includes a consultation, 20-30 minutes of pre-ceremony music, and all ceremony music by string trio, unless a custom piece is requested; **or** you can elect to have us play up to one hour of music after the ceremony

\$875 – *Ceremony and Cocktail Hour Package* - includes a consultation, 20-30 minutes of pre-ceremony music, all ceremony music, unless a custom piece is requested, and up to one hour of music for cocktail hour

\$75 - *Rehearsal Fee* - one of us will attend the rehearsal to lay out music and timing of songs

\$75/hour + \$.50/mile – *Travel Fee* - applies if your event is more than 25 miles from Midtown Tulsa

Custom Music Request - Custom Requests are charged on a per song fee. Prices range from \$5-\$25 per song if we can find sheet music for that song. Custom Arrangements are a flat \$35 per song. Requests and payment must be submitted to Save the Date Musicians no later than three weeks prior to your event.

\$200 - *Additional Musician Fee (per musician) Ceremony or Cocktail Hour* - applies if you request, through us, other musicians in addition to the standard trio, i.e. guitar, piano, quartet, etc.

\$250 - *Additional Musician Fee (per musician) Ceremony and Cocktail Hour* - applies if you request, through us, other musicians in addition to the standard trio, i.e. guitar, piano, quartet, etc.

\$75 - *Outside Musician Fee* - this fee applies if we have to rehearse with another musician of your choosing

\$50 - *Alternate Instrumentation Fee* - this fee applies if you request an instrument that's available within the performing trio that is not our standard instrument

1. PAYMENT - A non-refundable deposit in the amount of \$125.00 made payable to Save the Date Musicians is required to guarantee the booking of this event. Remaining balance of all other services shall be paid no later than seven (7) days prior to the event date, unless otherwise stated above. Payment Plans are accepted on a per case basis upon request. Payments are accepted by cash, check, credit card, or Paypal.

2. PACKAGE TIME FRAMES - Events that exceed the standard time frames beginning from the expected arrival and ceremony start times will be subject to an additional hourly fee of \$300 per hour for the performers, with a minimum of one hour charge. Fee will be billed after the date of the event. You agree to pay this fee should it apply to your event:

- a. The Ceremony Only package includes the following:
 - i. Twenty to thirty (20-30) minutes of prelude music while guests arrive
 - ii. All ceremony music
 - iii. Exit music
 - iv. All consultations to discuss music selections
 - v. Standard time frame for the entire ceremony package is seventy-five (75) minutes (1 hour and 15 minutes), including the prelude music up to through the exit music.

- b. The Cocktail Hour Only package includes the following
 - i. Up to one (1) hour of music during cocktail hour
 - ii. All consultations to discuss music selections
 - iii. Standard time frame for the cocktail hour package is one (1) hour

- c. The Ceremony and Cocktail Hour packages includes the following:
 - i. Twenty to thirty (20-30) minutes of prelude music while guests arrive
 - ii. All ceremony music
 - iii. Exit music
 - iv. Up to one (1) hour of music during cocktail hour
 - v. All consultations to discuss music selections
 - vi. Standard time frame for the ceremony and cocktail hour package is 150 minutes (2 hours and 30 minutes)

3. OUTDOORS - It is understood that some musical instruments, particularly stringed instruments, are extremely valuable and are susceptible to damage when exposed to certain climatic variations such as rain, wind, direct sunlight, high humidity levels and temperatures above 90 degrees Fahrenheit and below 55 degrees Fahrenheit. Therefore, performers must be provided with shelter from rain, snow, wind, or precipitation of any kind (under a tree is not acceptable cover), and direct sunlight in extreme heat. For outdoor events the temperature must be at least 55 degrees Fahrenheit and less than 90 degrees. The decision whether to perform outside will be made by the musicians at the time of performance, and you agree that their decision will be final. Performances may be moved indoors due to weather conditions. We do not supply cover of any kind. Supplying cover is the responsibility of the Client.

4. CANCELLATION-

- a. If the primary members of Save the Date Musicians are unable to play an event, substitute musicians will take their place for that event if available. Save the Date Musicians reserves the right to cancel this Agreement without obligation upon notice to the client. In the event of cancellation by Save the Date Musicians, for any reason, client will receive a full refund of fees paid minus their deposit and the cost of any music purchased or arranged.

- b. The Client reserves the right to cancel this Agreement prior to performance. In the event of cancellation by the client prior to seven(7) days before the event, Client will receive a full refund of fees paid minus their deposit and the cost of any music purchased or arranged. In the event of cancellation by the Client within seven(7) days of the event will require payment of any outstanding balance owed to Save the Date Musicians.

5. RESCHEDULED DATES - Changes to the originally agreed upon performance date will be looked at upon request. If we have the new date that you have requested free in our calendar, we will move to your new date at no additional cost, as long as there are no additional changes (duration,venue,etc.).

6. VENUE REQUIREMENTS - it will be the responsibility of the Client to ensure the following is available and provided at the venue:

1. Three chairs without arms
2. Adequate lighting to read our music (we do have stand lights)
3. A 6'x8' space to setup

7. VENUE CHANGES - Changing to a new venue more than 25 miles outside of midtown Tulsa will result in a travel fee (seeabove).

8. Save the Date Musicians does not provide sound or lighting equipment.

9. FORCE MAJEURE - Neither the Client nor Save the Date Musicians will be liable for failure or delay to perform obligations under this Agreement because of circumstances beyond the reasonable control of either applicable party. Such circumstances include without limitations natural disasters, other acts of God, acts of terrorism, labor disputes or stoppages, war, government acts or orders, epidemics, pandemics, outbreak of communicable disease, quarantines, national or regional emergencies, or any other cause beyond the party's reasonable control. The parties hereby agree, when feasible, not to cancel but reschedule the event for mutually agreed upon dates as soon as practicable after the force majeure condition ceases to exist.

10. Save the Date Musicians acknowledges the risk the we maybe exposed to COVID-19 by choosing to perform at your event. Save the Date Musicians assumes all risks and accepts sole responsibility for illness and any expense and consequences we may experience by attending live events.

11. Client agrees to notify Save the Date Musicians as soon as possible of any disease outbreaks, including Covid-19, that occurred at the event, should any happen.

12. Client agrees to adhere to local and state Covid-19 safety guidelines. Save the Date Musicians will be allowed, when physically possible, to set up at a safe distance (at least 6 to 10 feet) away from guests and the wedding party.

13. Client hereby releases, discharges, and holds harmless Save the Date Musicians, its performers, staff and owners, from Claims, including all liabilities, actions, damages, costs, or expenses of any kind arising. Client understands and agrees that this release includes any Claims based on the actions, omissions, or negligence of Save the Date Musicians performers or employees, whether a COVID-19 infection occurs before, during, or after participation in any event.
